





## What is the Payment By Outcomes Trial

Internally named by government as "PBO 3", the PBO Trial is a cross-sector collaboration between The Department of Social Services, White Box Enterprises, impact investors and jobs-focused social enterprise\* to create enhance employment experiences for people living with a disability.

- A three-year trial in partnership with Department of Social Services
- 16 participating jobs-focused social enterprises
- Up to 135 people living with a disability to participate in the trial

## **Trial timeline and progress**



- The Trial commenced on the 1<sup>st</sup> of July 2022
- The enrolment window closes on 30<sup>th</sup> of September 2023
- The Trial measurement window closes on the 31<sup>st</sup> of March 2026



## **Participant eligibility**

- not active in the labour market for 19 out of the last 26 fortnights (unemployed for 9 out of the last 12 months); or has an income that has not reduced Income Support payments for the last 12 months
- aged 16-59
- Receiving either:

  Jobseeker Payment + DES eligible; or
  CDP eligible
  Disability Support Payment; or
  Youth Allowance (Jobseeker) + DES eligible; or
  Special Benefit payment (Jobseeker) + DES eligible
- willingness to work (income threshold of \$513 per fortnight at commencement for reference)
- comfortable to provide informed consent regarding monitoring of income for the purpose of evaluation under the Trial



#### **HOW SOCIAL ENTERPRISE COMPARES**

Taylor Fry was engaged to compare preliminary PBO3 Trial results with existing publicly available data on DES, to determine how jobs-focused social enterprise performs against the current employment support model for people living with a disability.

#### 1. People start work sooner


When an individual is introduced to a social enterprise, they can start work immediately. Their training and development opportunities are part of their employment.

#### 2. They stay in work longer

Once an individual starts a job with a social enterprise, they are more likely to stay. Early-stage White Box data shows retention after 26 weeks with a social enterprise is at 85+%, compared to DES at 37%. Also noting the PBO3 Trial focuses on DES participants who been out of work for the last 9-12 months.

#### 3. They are earning more

Under the PBO Trial, individuals are estimated to earn \$28K in their first 12 months, 28% more than the average DES participant.





#### **HOW SOCIAL ENTERPRISE COMPARES**

#### 4. The PBO model is 17% more cost effective than DES

The government will save an estimated \$18,300 per person under the PBO model (based on 150 participants), equating to a \$2.75M benefit over five years


#### 5. No job outcome = no payment

Unlike a DES provider, a social enterprise only receives its first payment once the individual has retained employment for at least 26 weeks and earned a minimum of \$513/fortnight.

If the program could be scaled (noting the potential challenges of rapidly growing the social enterprise market), fiscal benefits would likely scale similarly. For example, a program that placed 10,000 people (about 3.6% of the Dec-22 DES caseload size) would see **fiscal benefits of \$183m** over a five-year period.



- 18-59 years old
- ability to undertake min. 8 hours per week

- Social Traders/NDS certification
- Diversity geography/size/industry
- Existing commitment to employment pathways
- Rap around support
- Willingness to participate

- Moving people to award wages
- Moving people through transitions to mainstream employment
